#### That's real commitment

## Work begins on new GPC warehouse

f you think "44 acres under roof" implies a pretty big place at which to work, wait until the Omaha Works Global Provisioning Center (GPC) warehouse in completed late in March 1997. With the addition of the warehouse's 400,000 square feet of floor space to current operating floor space, "44 acres" will become "nearly 54 acres under roof."

Ground was broken for the new facility in mid-July 1996 and construction is under way on the eastern portion of Works property. The warehouse is tangible proof that Lucent Technologies means business in its pledge to serve customers better than anyone else in the industry, with a focus on speed, innovation and quality.

#### Efficient, cost saving

Warehouse and distribution operations for products manufactured at the Omaha Works will be consolidated at the new facility, creating a more efficient and less costly operation to get products to customers much faster, according to project manager Larry Bailey.

"In the past, we have sent our products for storage at warehouses around the world before being sent to customers," he said.

"With warehousing and distribution alongside our factory operation, we can avoid handling things two or three times, as we ship equipment directly to customers-nationally and internationally."

# HISPA chapter hosts international conference

After months of planning and hard work by the Omaha chapter, the 10th Annual HISPA Conference will begin Thursday night, Oct. 3, 1996, and run through Sunday, Oct. 6, 1996, at the Red Lion Hotel.

The international conference will be historic: It will be the last conference that HISPA members and supporters from Lucent Technologies, AT&T and NCR will attend together. As the result of restructuring, the HISPA organization will then function separately as three Hispanic Associations of either Lucent, AT&T or NCR employees.

In the past decade HISPA, which is an employee resource group dedicated to the development, growth and advancement of Hispanics, has grown to 20,000 members internationally, with 42 domestic chapters and seven international chapters.

## Countdown to the spinoff

On Sept. 30, 1996, investors who bought AT&T stock by Sept. 17, 1996, will divide 524.6 million shares of Lucent. Each AT&T shareholder will receive about one Lucent share for every three AT&T shares.

On Oct. 1, 1996, Lucent officially will be operating as a new, stand-alone company in the marketplace.

## New GPC warehouse slated for March '97 completion

(Continued from Page 1) GPC warehouse is occurring across Network Systems to accomplish "whole order delivery," a feature that appeals to customers.

This means that parts from other manufacturing locations relating to equipment made at the Omaha Works can be brought to our warehouse where "all of the components of the final product may be packed and shipped to our customers at the same time," instead of being shipped at different times from different places, Bailey explained.

Network Systems' Merrimack Valley, Oklahoma City, Atlanta and Columbus (Ohio) Works locations also will have their own GPC warehouses.

Although the square footage of

Omaha's GPC is impressive, the actual storage area for products will be less than the combined space we have had at material management centers (MMCs) in the past.



1995 were cleared. However, two NCNs involving Bell Labs issues at Atlanta and Whippany, N.J., remain open and will be reviewed at the next surveillance audit.

Lloyd's Register Quality Assurance (LRQA), which conducted the audit, issued only one non-compliance note this time around to the Works. No NCNs were issued to the Indianapolis Bell Labs location, which was audited for the first time.

The next surveillance audit is scheduled for January 1997, but LRQA representatives will not be visiting the Works. Rather, the audit will focus on copper apparatus and wire issues in Atlanta and Whippany.
