



Schaffer: Organizations often fail
to reach a goal because they pick
the wrong one. Or they expect to
accomplish too much in a short
time. To avoid failure:
--PICK a compelling goal that grabs
attention--one that everyone will
see as vital
--MAKE SURE you can divide the goal
into steps, with the first step
reachable in weeks, not months or

years
--AVOID FUZZY statements, such as
"to improve quality." The goal must
have measurable, bottom-line results
--SELECT a goal that makes people
say "It's about time we did this."
If they say, "Oh, no, not this
again," you've picked the wrong

JUST WHAT IS PQMI, ANYWAY?
PQMI is an acronym for Process
Quality Management and Improvement.
The methodolgy of PQMI is based on
a two-phase cycle: first, MANAGING
THE PROCESS and secondly, IMPROVING
THE PROCESS. This cycle is
continuously repeated. Tasks are
performed at four points within
these management and improvement
phases:

OWNERSHIP--To ensure that someone is in charge of the process and that a team carries out day-to-day quality management activities.

ASSESSMENT--To study and clearly define the process, identify customer expectations and requirements and clarify internal business objectives.

OPPORTUNITY SELECTION--To understand how internal process problems affect customer service and to identify and rank (in order) the opportunities for process improvement.

IMPROVEMENT--To achieve and sustain a new level of process performance made possible by this new action plan.





Plant and Trades supervisor DALE KARLOFF is also recovering from quadruple coronary bypass surgery on Oct. 5. He's recuperating at home at 6520 Cypress Drive, Omaha, NE 68137. Karloff's fellow trades supervisor, JULIUS SONDERMAN, is back at work following coronary angioplasty in September.

An Omaha Works engineer made it through the Oct. 17 quake ordeal with no injuries. IBU 558 Production Engineer STEVE ZERBS was attending a trade show and conference at a large, new exposition center in downtown San Jose (about 10 miles northeast of the epicenter) when the quake occurred. Zerbs recalls "the quake felt like two frequencies -vibration and rolling." Everyone evacuated the block-long building, which sustained little damage. Steve did remember vividly one detail of the ordeal: "The 2-foot EXIT signs suspended above the doors from the 20 foot ceiling swung both ways with enough force to hit the ceiling on both sides (of the sign)." Zerbs saw dust rising immediately from buildings in the downtown area and felt several aftershocks. He also estimates nearly two feet of water sloshed out of the hotel swimming pool.

HERSCHEL ATCHISON, IBU 551-2 section chief in the cable shop, was waiting for a traffic light to change while aboard his son's 18-wheeler tractor/trailer truck near Hollister, CA when the earthquake occurred. (Hollister is only a few miles from the earthquake epicenter). "I didn't know what it was at first. It felt like someone hit us from behind and came up under the trailer. Then it stopped and started again. rockin' and a rollin'." Atchison's son, Bob, is an independent trucker who often hauls produce from Salinas, CA. The two men weren't injured and remarkably didn't see any devastation from the quake. Atchison often travels around the country with his son and adds "In my travels, I deal with a lot of different long distance operators. Our operators (AT&T) are still the best."



MIKE JAEGER, IBU 577 (Tool and Die), says his daughter was really HAPPY IT WAS ONLY AN EARTHQUAKE. Here's the story: Daughter CHRIS was driving the 20 miles from Palo Alto to her home in Fremont, CA when her brand-new maroon 1990 Mercury started to shake, rattle and roll, Jaeger says "Chris was furious. This was her second new car in one month. Her first car was a new 1989 that had to be repainted three times. Finally, the dealer gave her a new 1990. When things started to vibrate from the quake, she thought she was having both tire and engine trouble. She thought she had another lemon! She was relieved to find out it was only an earthquake. ANYTHING BUT MORE CAR TROUBLE!" Chris and her family weren't injured in the quake. (By the way, Chris's father-in-law BENNIE WOLLBERG, formerly of Omaha, works at AT&T's San Leandro MDC, which will be closing. Maybe he can go across the street where his wife works. They're quite busy and will be for some time -- the senior MRS. WOLLBERG works at a plate glass window business.)
