The monthly membership meeting will be held Thursday, November 17, 1994, in the Small Meeting Room, 13306 Stevens Street, Omaha, Nebraska.

Third Shift Meeting: 8:45 a.m. Second Shift Meeting: 2:00 p.m. Day Shift Meeting: 4:15 p.m.

PRESIDENT'S MESSAGE

Employment here at Omaha will be increasing again by upwards of 200. This is the second increase of employees this year. Business is growing, both in increased orders of product we currently make, as well as in new product lines we are entering. Omaha is very fortunate in that $\frac{\text{most}}{\text{year}}$ AT&T Manufacturing facilities are laying off. The orders for next year look even better than we had this year.

As per our Agreement, 200+ job vacancies were posted in "ATS" transfer system and 140+ AT&T employees expressed a show of interest. This number will probably change when those who expressed interest must decide whether or not they really wish to move. The Nebraska Job Service has already supplied a list of "new" personnel who would like to work here. The plan is to get all openings filled and people on Omaha's roll before January 1st.

Again, a large number of Level II jobs will be posted, as well as some Level III's that need to be filled. Because of time and attempting to fill Level I needs "ASAP," the posting of Level I jobs for lateral bid will be done only by posting 10--12 per month and not all at once. Remember, to bid laterally on a Level I job, you must be in your current job for at least $\underline{\text{six}}$ months.

Last week, a posting of Level III's for 22C - Molding was put on the board. The qualifications for this job were "BROADENED" by including extruding experience, in level II, as well as former level II molding experience. This has upset some of the members because they had been "the next in line to get the job" based on the old qualifications, but now because of service, they may not get the job.

Discussions between the Union and the Company as to qualifications of this job have been on-going for the past three to five years. We have had grievances on the "old" qualifiers by members of long service who have had jobs that they felt should have been included as qualifiers and were denied this level III. It has been a known fact that the "pool" of qualified people kept getting smaller and smaller, and sooner or later, it had to be addressed. Before the last posting of this job, there was a discussion of broadening the qualifiers, but because it was already "common" knowledge that four openings were waiting to be posted, we decided to hold off that change until after that posting. That being done, I agreed to now change, and expand those qualifications. THIS WAS NOT DONE WITH ANY OTHER INTENT!

To "exhaust" the pool of previously qualified people, or to, worse yet, change it the <u>next</u> time would not be in the "<u>membership's</u>" best interest, because this would have set off a whole new set of problems, I also want to say that having to have "<u>extrusion</u>" experience makes sense for this level III job, while still maintaining lower graded molding experience.

I would remind the members of this:

Prior to 1986, you had to have a very specific 32 graded job to QUALIFY for even 33 grades in 30 building, as well as very specific 33 and 34 graded jobs to qualify for 35. This all changed in 1986 with the three level plan, and we need to be reminded that the ONLY qualifier for a level II is seniority. The Company and Union have BROADENED qualification bases of all EW&C level III's. We have "BROADENED" the base qualifications for level III in our storeroom positions as well. I do not feel that we should exhaust any one pool of people first, before we change something like this, because that is being "reactionary" and not pro-active as we should be.

"If not now -- then when."

It is not <u>fair</u> nor <u>justifiable</u> to have only those things changed that affect us in a positive way, and disavow changes that affect others in a positive way.

I will be out of town at a President's Meeting this week, but I want to wish everyone a very happy holiday.

We will be giving away \$20 gift certificates at our Monthly Meeting. There will be $\underline{50}$ certificates available between the three meetings.
