Steve said, "I felt the impact on my glasses and I won't have a problem wearing my safety glasses in my work area again."

Steve will be the newest member of the "Wise Owl Club" when it restarts up after the first of next year, according to Rich Schmitz, Safety Supervisor.

On September 25, 1994 through September 29, 1994, Rich Schmitz, Kathy Scott, Local Union 1614; Deb Gulizia, Local Union 1974 and I attended the 10th Annual National VPPA Convention in Phoenix, Arizona, in which the theme was "Soaring to New Heights of Excellence."

We attended classes on egronomics and labor and management relationships. We spent considerable time with Arlene Greene, IBEW Union Officer out of Shreveport, Louisiana. 
