PRESIDENT'S MESSAGE

At our May Business meeting, a bylaw proposal that was submitted in April was defeated. The results were:

The following is an example of an overtime situation:

Saturday - need two people per shift - 3 shifts.

First 2 - day shift employees

Schedule as follows:

The 2 lowest, who are day shift persons, have to be moved (asked) to work 3rd shift because the next lowest 4 people are 2nd shift and could not work the 3rd shift on Saturday a.m. slots. As it would then stand, after the first $\underline{2}$, the second $\underline{2}$ would be scheduled on the $\underline{2}$ nd shift, and the remaining $\underline{2}$ would have to be scheduled for day shift.

PLEASE REMEMBER:

Shift Selection Sheets in your current overtime pool, MUST be filled out if you are wanting another shift.

Please check on this.

It must be signed by you, and be done before the vacancies are posted.

SHARES FOR GROWTH

To be eligible for \$1,800 (minus taxes) you MUST be on the ACTIVE ROLL of AT&T ON SEPTEMBER 1, 1994!; and NOT on any kind of "Leave of Absence."

Effective October 14, 1994, all eligible regular occupational employees will receive a Shares for Growth Payment equal to a minimum of \$1,800 in accordance with the provisions specified herein.

Eligibility Criteria for October 14, 1994 Shares for Growth Payment.

- 1. Employees on active roll as of September 1, 1994 who have an NCS date of August 31, 1993 or earlier are eligible to receive a Shares for Growth Payment.
- 2. Employees who are recalled from layoff, reinstated from a Leave of Absence for Anticipated Disability, or reinstated from a Leave of Absence Due to Union Business prior to August 1, 1994 who have an NCS date of August 31, 1993 or earlier are eligible for the Shares for Growth Payment.

Application of the Shares for Growth Payment to other Benefits, Allowances or Allotments.

For the 12 month period following the October 15, 1992 Shares for Growth Payment, and for the 12 month period following the October 14, 1994 payment, the payment will enter into computations of overtime worked and shall be included in the calculation of the following benefit payments or allotments:

Group Life Insurance Supplemental Group Life Insurance Death Benefits Savings and Security Plan Where appropriate, these payments will be used in determining deductions for union dues. (THIS WILL NOT APPLY FOR LOCAL 1974, AS IN THE PAST.) The payment will not be part of the employee's standard rate of pay or basic wages for any other purpose nor shall it enter into the computation of any payments made under any other pension or benefits plan, fringe benefits, allowance or differential.

Shares for Growth Payments

1. Award payments will be made in the following manner:
Payment amounts shall be subject to federal, state and local
tax and FICA withholding. For employees who participate in
the Savings and Security Plan, the payments shall be included
in a calculation for the Savings and Security Plan. After
the deduction of such applicable taxes, SSP amounts, the
remaining amount will be used to purchase shares of AT&T stock.
The October 14, 1994 payment amount less applicable taxes, SSP
and divided by the lesser of the average of high and low per
share price of AT&T stock as listed on the New York Stock Exchange on September 21, 1994 or the average of the high and
low per share price of AT&T Stock on September 21, 1992, will
equal the number of full shares of stock the employee will
receive for the October 14, 1994 award. Any remaining amount
(less than the equivalent of the price of one (1) share)
will be paid by check.

HEALTH CARE NETWORK PARTICIPANTS

Blue Cross and Blue Shield has recently made some changes in the administration of their health care networks. Your benefit coverage will not be affected and you will not have to select a new Doctor of Choice (DOC).

Effective July 1, 1994, you'll have a new dedicated 800 HELPLINE phone number for the Blue Cross and Blue Shield local network where you live. By dialing your local network, your calls can be answered faster. It will be accessible nationwise for all members, including out-of-area dependents, and it will use the same <u>local</u> service hours, 7:30 a.m. to 5:30 p.m.

Also, effective July 1, you'll be able to send all of your claims (i.e., prescription drugs and out-of-network claims) to your local network for faster, in-state processing. Claim forms have been redesigned to make filing easier, and you'll have local area expertise to help you.

In late June, you'll receive additional information from Blue Cross and Blue Shield about your new Local HelpLine phone number and address, a new claim form, and a new ID card for yourself and your covered dependent(s). Your new ID card will look just like your existing one, but will show the name, phone number and address of your local Blue Cross and Blue Shield network. It is important that members use their new ID cards after July 1, 1994. Any old identification cards and old claim

forms should be destroyed.

Remember, no changes will be made to your benefits. These administrative changes are only being implemented to improve the quality of service provided by your local Blue Cross and Blue Shield network.
