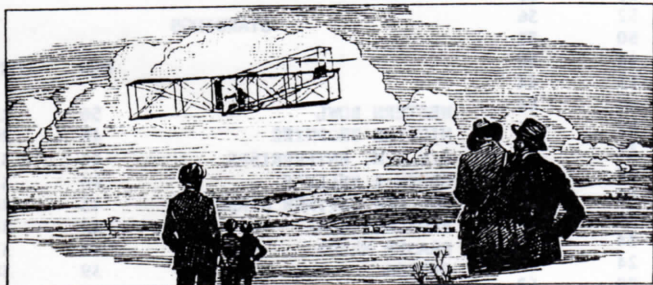

The Conquest of the Air

The first chapter of the inspiring story of man's conquest of the air was written eighty-six years ago when, on December 17, 1903, the Wright Brothers lifted their frail plane from a North Carolina sand dune.

Other chapters followed, as these pioneer birdmen or their successors designed and built heavier-than-air machines which flew higher, covered greater distances, made their journeys more safely. One of the most absorbing of these is that which records the contributions to aviation made possible by the development of the radio telephone and other forms of communication, derived from it, by means of which contacts may be maintained between planes in flight and the ground, or other planes, or ships at sea. Research and experimentation in this field of communication, much of which has been carried on by scientists and engineers, have gone far toward promoting the safety of pilots, passengers and planes.

The importance of communication to aviation is made manifest not alone when some daring birdman, crossing open sea or arctic ice, is guided to his goal by the radio telephone. Not less clearly is it written in the daily record of scores of commercial planes which, forewarned by the spoken word against mischance, safely reach their destinations.

Still other chapters of the history of the conquest of the air remain to be written. One of them is destined to be story of the continued development of communication to meet the new needs which the future of air navigation will develop.

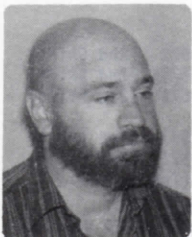
gift for that person. The gift should be in the \$5 to \$10 range.

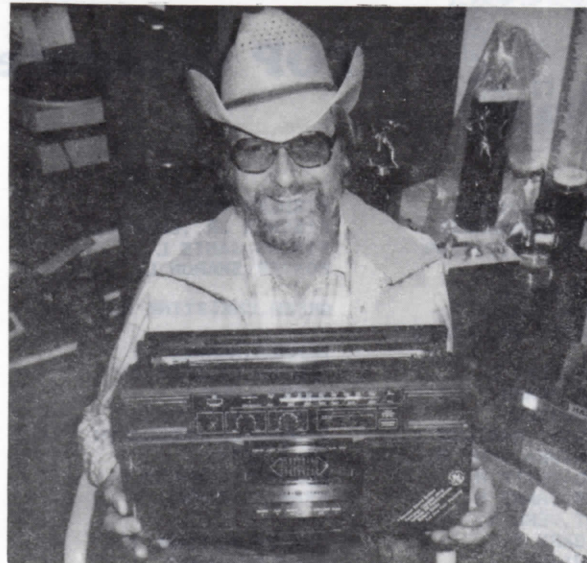

TRIVIA ABOUT "A HEALTHY HEART"-

1. If you are obese, 20% or more over your ideal weight, how can you reduce the strain to your heart?
2. Is your risk higher if a family member had coronary heart disease or other risk factors?
3. Do men have a greater risk of a heart attack than women?
4. Does everyone get atherosclerosis?
5. Can you substitute healthier habits for unhealthy ones?

ANSWERS-

1) By reducing your heart will not have to work as hard. 2) Yes. Your risk is higher still if you are a man with a relative who died of a heart attack at an early age. 3) Yes. Men under 50 have a 2 to 3 times greater risk than women of the same age, who have higher levels of "good cholesterol." Beyond that age, their risk is about equal. 4. Yes. So, as you become older, it's even more important to strip away those risk factors that you can control. 5) Yes. Substitute carrots for potato chips, or low-fat flavored yogurt for ice cream.

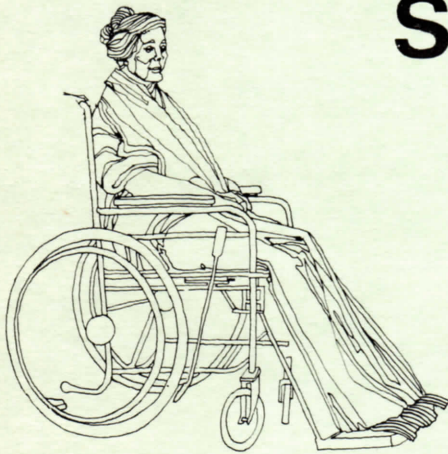

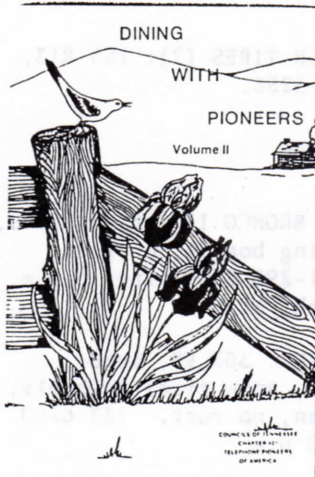

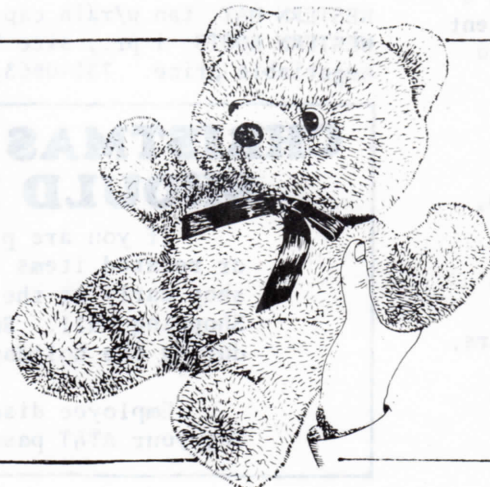
