Pioneers to Resume Can Collection at Omaha Works; "Name the Project" Contest Deadline Aug. 1

The magnificent success of the previous can collection project at the Omaha Works, "Cans for Kids", is being renewed by the Cornhusker Chapter of the Telephone Pioneers, according to Administrator Bob Miller.

For two years employees in Dept. 597 volunteered their time collecting cans on the premises and raised over \$15,000.00 in their recycling effort. The funds were donated to organizations helping children in the Omaha community.

Miller said a new name for the program is being sought and a contest will be held among employees beginning today and running through August 1. A contest entry form can be found on this page and should be filled out and returned to the Pioneer office located in the Employees Activity Mall. The winning "Name the Can Drive" entry will receive a \$30.00 gift certificate to any restaurant selected by the winner.

Tom Baye, the new Life Member representative for the Chapter in charge of the project, said 15 collection bins will be placed throughout the plant - in cafeterias, break areas and by the office elevators. Collection bins are also to be placed in the Cable Plant (Bldg. 50) and Crossbar (Bldg. 30) parking lots.

Baye also noted that Active Pioneer members will collect the cans after work hours and take them to a semi-trailer (parked in the trailer lot on the premises) that will store the cans until delivery for recycling.

Frank Kros, section chief in Dept. 573, is helping to coordinate the drive. He played a key role in the "Cans for Kids" project that ended earlier this year.

The money collected from this recycling effort will go to the Cornhusker Chapter's charitable fund. Specific programs and charities in the community will be the ultimate recipients of the funds.

As with any charitable effort, volunteers are needed to make this project a success. Those wanting to help gather the cans and set them in the outside collection bins should contact the Pioneer office. It will take very little time and be of so much help.

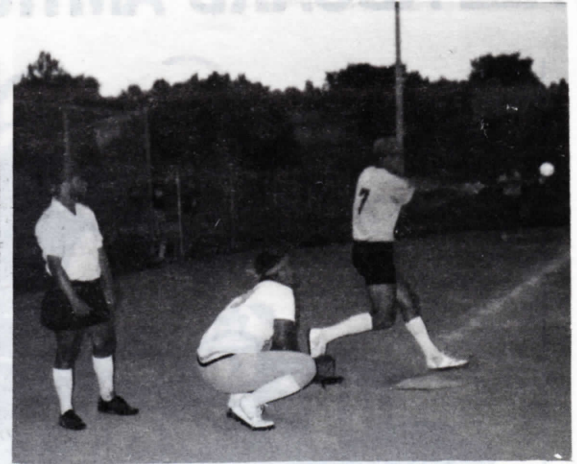

Haluza Scores Hole-in-One; Eagle for Seaton at Elmwood

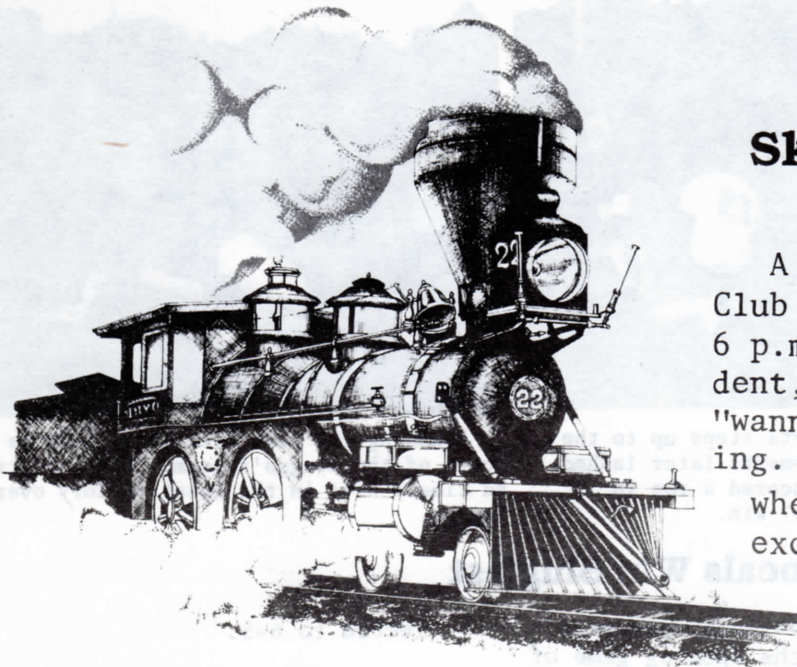
Don Haluza, who is retiring from AT&T this week, recorded his first-ever hole-in-one during Monday Night Mixed League play at Westwood Heights.

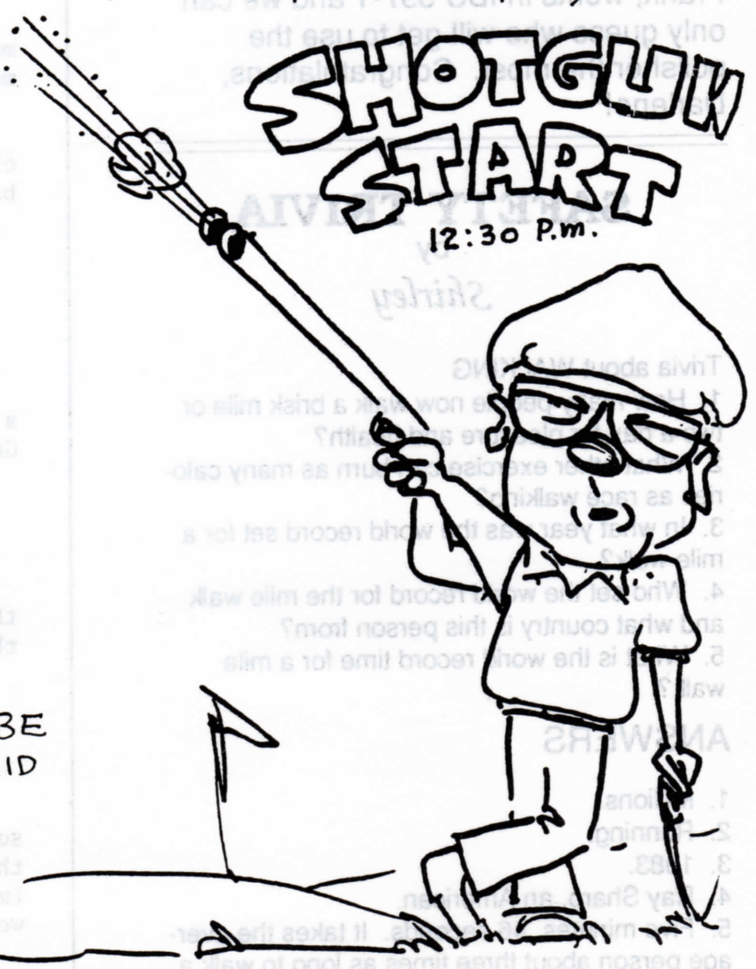

Dare To Be Safe!

Child Safety Seats—

In a sudden stop or crash, all occupants in the vehicle continue to move forward at the same speed the vehicle was traveling, until something stops them. Children are especially vulnerable in a collision because their heads are the heaviest part of their bodies and they often sustain serious head injuries as their heads fly forward.

Child safety seats work like safety belts, protecting the passenger, except that they are

more effective for young children. They distribute the shock and crash forces across the strongest parts of the child's body and prevent the child from striking hard surfaces of the vehicle's interior or other passengers.

Safety seats are extremely effective in preventing death or injury in young children. Children under 40 pounds must ride in an infant or convertible safety seat. Adult safety belts should only be used for small children in the case of an emergency, when no child safety seat is available. Use only child safety seats that are certified to meet federal safety standards. Follow manufacturers' instructions.

Proper installation is an important concern. The seat must be correctly strapped to the vehicle. Face infants toward the rear of the vehicle. Fasten safety seat with the vehicle's safety belt, properly routing the belt through the safety seat frame according to the manufacturer's instruction. Fasten the child seat harness snugly over the child's shoulders.

At least 30% of child safety seats are not used in a manner that provides maximum protection. The most common error is improperly anchoring the seat to the vehicle. Thread the vehicle's safety belt around the seat properly.

In the state of Nebraska, it is a law that all children under the age of 4 years must be in a child safety seat. Children between the age of 4 and 5 years must wear safety belts. Adults riding in a car with small children must also wear safety belts. Although Nebraska does not have a safety belt law for adults, those not buckled in the event of an accident create an open system. Their flailing bodies in an accident have been known to cause death to small children.

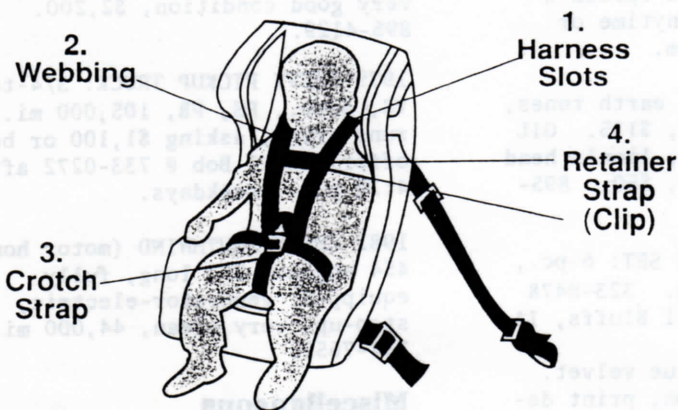
When transporting children, please be sure that both the children and adults in the vehicle are buckled up. Remember to select a child safety seat that fits your child and your vehicle. Use it correctly and use it every time your child rides in a vehicle.



SAFETY CHECK

Is your child properly secured in the seat? Check these points.

- The shoulder harness should go through slots (1) level with or just above the shoulders.
- The webbing (2) must lie flat and not twisted.
- Straps must fit snugly. Readjust to allow for the thickness of the youngster's clothes.
- The crotch strap (3) should be kept short.
- The retainer strap or plastic clip (4), if provided, should be high enough to keep the harness from slipping off the shoulders.
