Stings and bites

♦ If you like outdoor activities, sooner or later you will probably be stung by a bee, wasp, hornet, or yellow jacket. Reactions to such stings can range from mildly painful to life-threatening. Therefore, it is prudent to do what you can to avoid being stung. Insect bites are usually less painful and hazardous than stings, but they too are often itchy and irksome enough to require relief-giving measures.

What can you do to avoid stings?

· Keep collars and sleeves buttoned or closed.

Wear smooth-textured clothing in subdued colors. Rough textures and bright colors may attract agitated bees.

Don't go barefoot.

- Bees are more likely to sting in gloomy weather than on bright, sunny days, so take greater care to avoid them at such times.
- Smoke has a calming effect on bees, so beekeepers often use a smoke canister to control their activity.
- · Never strike, agitate, or throw an object at a bee or wasp hive.
- If caught in or near a swarm of bees or wasps, move away with slow, deliberate movements. Do not swat at them.

What should you do if you are stung?

- Apply ice or cold compresses to the sting for relief of pain and swelling.
- If you see the stinger, remove it gently with a tweezer as you would a sliver.
- If you feel dizzy or faint, are short of breath, have trouble breathing, or break out in hives or welts, get medical help as quickly as possible. These are symptoms of an allergic reaction.
- If you are allergic, your doctor will treat you with the appropriate medications and will prescribe epinephrine and/or antihistamines that you can keep with you to administer quickly in case of future stings. Prompt treatment will save you the misery of a prolonged painful sting reaction and may save your life.

What can you do to relieve itchy bug bites?

- Ice is a cheap, readily available anesthetic that can blunt or even eliminate the itch and pain of bug bites.
- Itch-relieving lotions that contain menthol, phenol, camphor, or local anesthetics may be of some help.
- Oral antihistamines (which you can buy without a prescription) reduce the reaction and are a mild sedative.
- If you have a great many bites or if reaction to a bite worsens or persists, see your doctor.


